MEMORANDUM FOR THE DEPUTY SECRETARY OF DEFENSE

SUBJECT: Records and Reports of Pacific Atmospheric Nuclear Testing, 1946-62

1. References:

- a. ASD(MRA&L) memo of 28 Jan 1978, subj: DoD Personnel Participation in Atmospheric Nuclear Weapons Testing.
- b. ASD(MRA&L) memo of 1 Aug 1978, subj: Ionizing Radiation Inquiry.
- c. USDRE memo of 15 Dec 1978, subj: Utah Radiation Exposure.
- 2. On 16 May 1979 representatives of the new government of the Marshall Islands attended an interagency meeting in Washington called by the Department of Interior (DoI). The purpose of the meeting was to permit Marshallese government representatives to raise questions regarding radiological conditions in the Marshalls with representatives of the U. S. Government (principally Interior, Energy, Defense (DNA), State, and the Micronesian Status Negotiations Team).
- 3. At the meeting, representatives of the new Marshallese government requested, inter alia, that they be provided all pertinent records and reports from the Pacific atmospheric testing, 1946-62, bearing on radiological contamination of the Marshalls.
- 4. On behalf of the Defense Department, Director, DNA accepted this responsibility as regards DoD records and reports which are or could be declassified. This action was taken in accordance with references a. and b., which establish DNA as the DoD Executive Agent for all matters pertaining to atmospheric nuclear test participation (reference a) and ionizing radiation exposures (reference b). This also parallels DNA's responsibilities under reference c. for provision of similar reports and records to the Governor of Utah as regards radiological contamination from testing at the Nevada Test Site.

Dear Mrs. Van Cleve,

At the May 16 interagency meeting in Washington, D.C., which you called at the request of the Government of the Marshall Islands, Mr. Anton DeBrum, Secretary of Foreign Affairs to the Government of the Marshall Islands, requested information concerning a U.S. Navy ship which visited Likiep Atoll in March 1954, shortly after the BRAVO shot of Operation CASTLE.

As the Department of Defense representative at the meeting, I accepted the responsibility for providing him with information on this event. Because of the differing nature of the responsibilities of our respective Departments with respect to the Government of the Marshall Islands, I am providing the information to you for submission to Mr. DeBrum.

Enclosed are copies of seven letters and memoranda relating to radiological surveys, evacuations, etc., in the Marshall Islands after the BRAVO shot. They contain, as enclosures,—some 13 other documents, plus attachments,—with the entire packet numbering about 100 pages. Included is the record of the visit of USS RENSHAW (DDE-449) to Likiep Atoll on 6 March 1954 (a few days after the detonation).

The Defense Nuclear Agency (DNA) is still at work retrieving the more extensive data Mr. DeBrum requested—that dealing with radiological contamination of the Marshall
