2. Travel directed herein is necessary. Travel by MATS or other military aircraft or military water carrier is authorized. No expenses (other than transportation in kind) incident to this travel will be chargeable to Joint Task Force SEVEN. All expenses incident to this travel will be borne by the employing agency. Changes in the above itinerary are authorized to proceed to such additional places as may be necessary for the accomplishment of this mission.

3. Unless specifically authorized, individuals will not have in their possession at, or in the vicinity of, the ABC Eniwetok Proving Ground any of the following; all photographic equipment; all visual or electronic communication equipment; all optical equipment other than eyeglasses normally worn; all explosives, weapons, ammunition and drugs.

4. Mr. Dunham is authorized to have in his possession and custody. Drugs and Narcotics to be used in the performance of his duties.

Mr. Riegel is authorized to have in his possession and custody, Engineer's Transit, Level, and Machete to be used in the performance of his duties.

Mr. Rowe is authorized to have in his possession and custody, Engineer's Transit, Level, and Machete to be used in the performance of his duties.

Mr. Yoshioka is authorized to have in his possession and custody, 50 Boxes of Dynamite, 1 Box Blasting Caps, and two Rolls Prima Cord.

5. Individuals are "Q" & "L" cleared and are considered good security risks under the provisions of CINCPAC Serial 020 for entry and re-entry into the Eniwetok Proving Ground area for the duration of this temporary duty and authority for their entry and re-entry into the above specified areas of TERRAPACIS during this period of temporary duty has been obtained in accordance with CINPACFLT INSTRUCTION 5521.14, dated 10 November 1952. Each individual has in his possession an AEC Identification Card.
