6 APRIL AND DISCUSSIONS WITH YOUR MEMBERS, CORAY, JEFFCOAT,
CRENSHAW, OUR MR. SCHLACKS AND THE WRITER, SEEKING TO FIND
A PRACTICAL SOLUTION FOR COMPLETION OF WORK ORIGINALLY
OUTLINED BY MR. CHELIUS OF LASL.

THE WORK OUTLINED BY MR. CHELIUS, WHICH HAS BEEN PROSECUTED
OVER SOME PERIOD OF WORK BY DIRECTION OF MR. H. H. LEVIS
TO YOUR OFFICES, STILL REMAINS INCOMPLETE WITH RESPECT TO
THE FOLLOWING:

1. HOT-SPOTTING AROUND TENTS.
2. BACKFILL OF TRENCHES AT TENTS AND ADJACENT AREAS.

OUR ANALYSIS OF THE RESULTS TO BE OBTAINED AND TECHNICAL
ADVISE OF MR. HUGGINS OF THE UCRL GROUP INDICATE THE
ADVISABILITY OF COMPLETING THE WORK WITHIN THE ORIGINAL
CONCEPT. THIS WILL REQUIRE:

1. WASH DOWN OF TENT SLABS WITH PARTICULAR CARE AROUND
EDGES OF SAME.
2. BACKFILLING OF TRENCHES AND ALL AREAS BETWEEN TENTS
AND EXTENDING APPROXIMATELY 30' BEYOND THE TENTS TO A DEPTH
OF 4".

THIS FILL TO BE MADE OF UNCONTAMINATED MATERIAL SUITABLE TO
THE PURPOSE. IT IS PROBABLE THAT AREA EXAMINED ON 6 APRIL
ON SITE SALLY WILL, AFTER STRIPPING OF SURFACE, PROVIDE

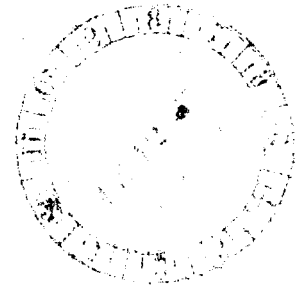
