REVIEW OF PROGRAM FOR OPERATION HARDTACK

Report to the General Manager by the  
Director of Military Application

1. At Meeting 1280 on May 1, 1957 the Commission considered AEC 952/5 (Test Activities for Calendar Year 1958) and:

a. Approved, for the purpose of guidance to the weapons laboratories and other agencies involved in the planning for Operation HARDTACK, the general scope of the test program, described in paragraph 11 (of AEC 952/5), of approximately 27 shots;

b. Noted that the actual test program for Operation HARDTACK would be presented to the Commission for consideration at a later date.

2. On August 2, 1957 the Chairman informed the President by letter (AEC 952/12) of the status of plans for Operation HARDTACK and the general scope of the test program. This letter noted that a series of approximately 25 shots would be initiated about April 1, 1958 and would be completed within four months. It was also noted that a listing of devices to be fired and materials to be expended would be submitted to the President later.

3. On August 9, 1957 the President discussed with the Chairman the subject of the letter of August 2 and, as reported by the Chairman at Meeting 1300 on August 13, 1957:

a. Approved our proceeding now with preparations for Operation HARDTACK with a starting date of April 1, 1958;

b. Directed that the planned firings (approximately 25) be screened to hold to the smallest number practical without losing essential defense objectives;

c. Requested that every effort be made to shorten the length of the test period.

4. On August 13, 1957 the laboratories and ALOO were informed of the President's desires by a message which stated, in part:

"Personal and eyes only to Bradbury, York Sewell and DiLuzio from Starbird

"In our meeting of 1 August we agreed Commission submission to President of plans for HARDTACK would be on following basis: Approximately 25 shots (of which 5 would be DoD effects shots); series would begin 1 April 1958 (and I added lasting about 4 months). Submission was so made. President expressed interest in starting earlier but was informed that this was earliest balanced series could be started. He was surprised at the high total and directed that number be held to minimum consistent with realizing essential military objective. He directed that plans, preparations and evidence that U.S. intends a series be carried forward on a classified basis and that there be no repeat no public release indicating this intent without his further review. It is evident that he hopes to delay this as public information as long as possible."

As a result of the meeting which followed, the laboratories submitted their proposals for shots to be included in the test program for Operation HARDTACK. The UCRL proposals are contained in a letter from Dr. York dated August 23, 1957 (Appendix "A"). Dr. York has been asked since to screen further his plans. The LASL proposals are contained in a letter from Dr. Bradbury dated September 23, 1957 (Appendix "B").

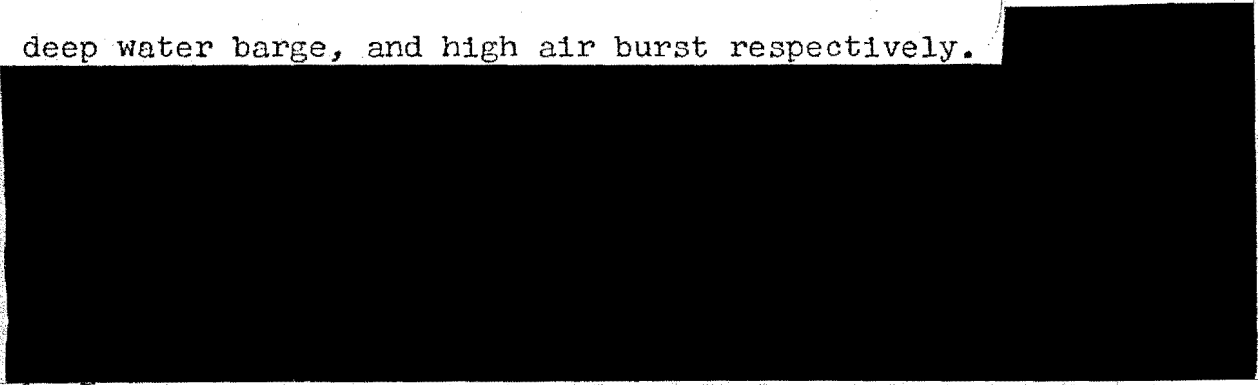
5. The contribution to world-wide fallout of the test shots being considered by the laboratories (and including the 5 shots which are being sponsored by the Department of Defense) has been estimated from the probable total and fission yields. The estimate was based on using 20, 50 and 100 percent of fission yield distributed world-wide for surface or shallow water barge,

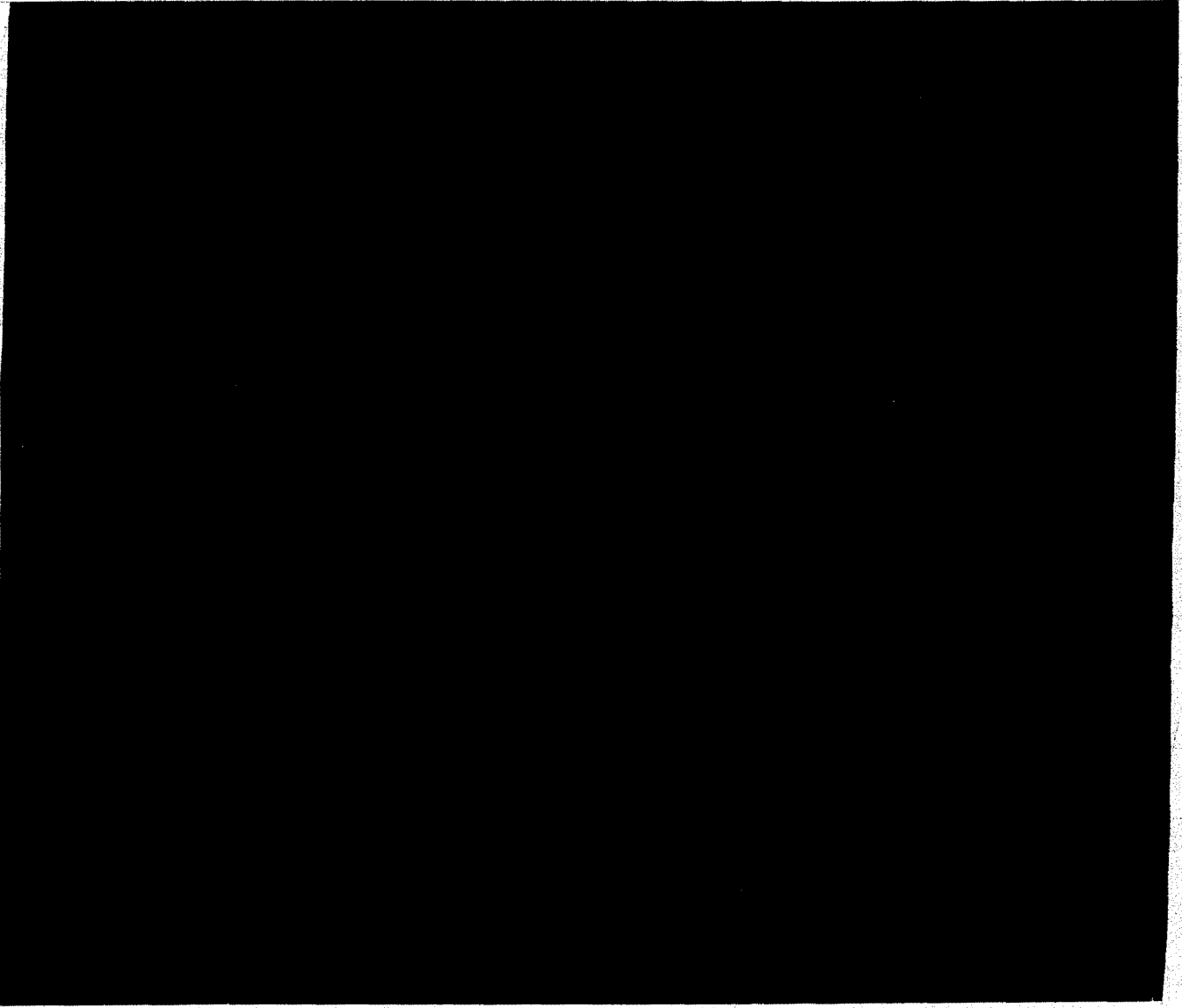

It is necessarily tentative because some of it depends on future Plumbob results, some of it depends on unresolved problems of relative priorities, and because of still uncertain estimates of what our own capabilities are in view of the shortened between-test interval.

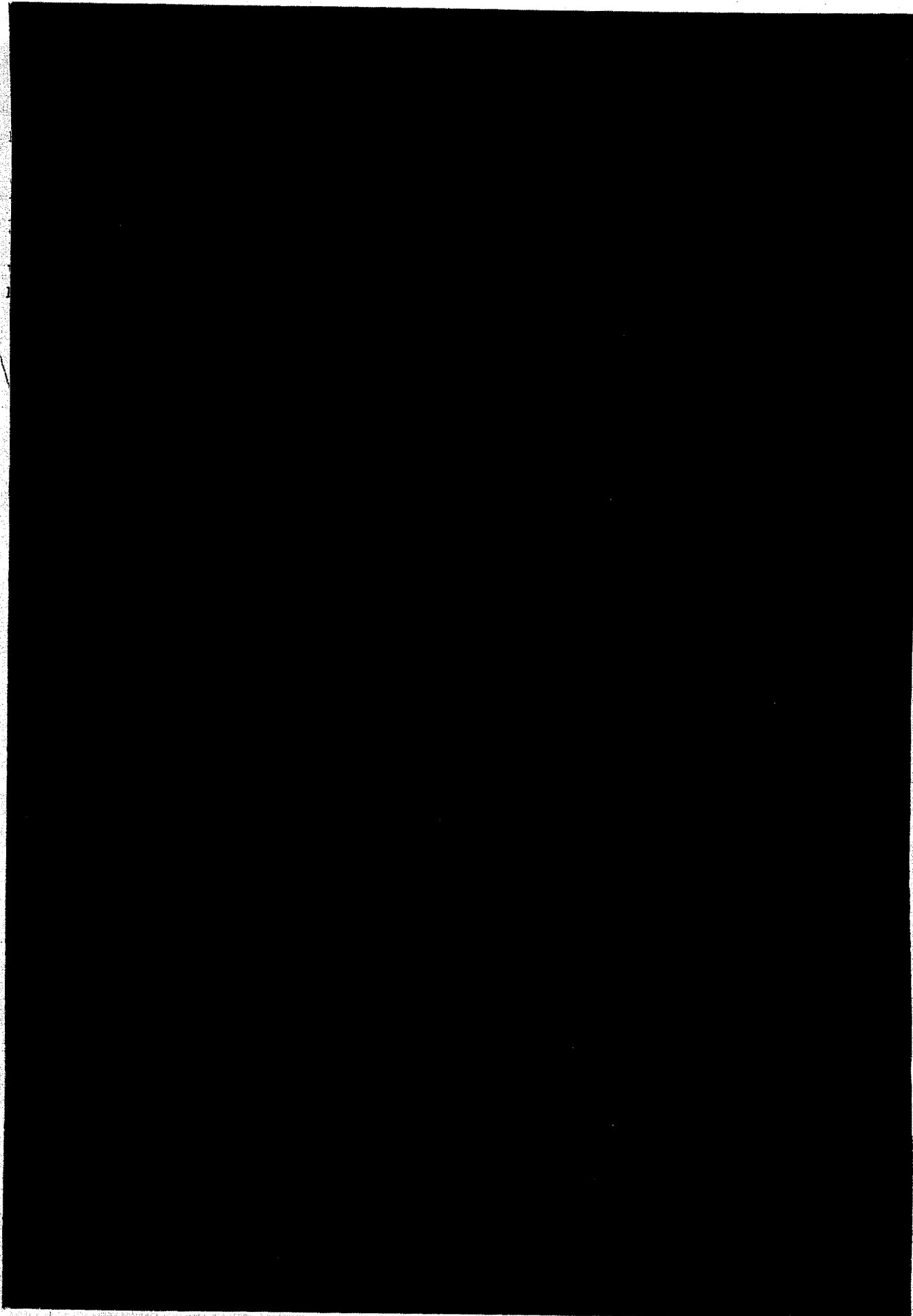

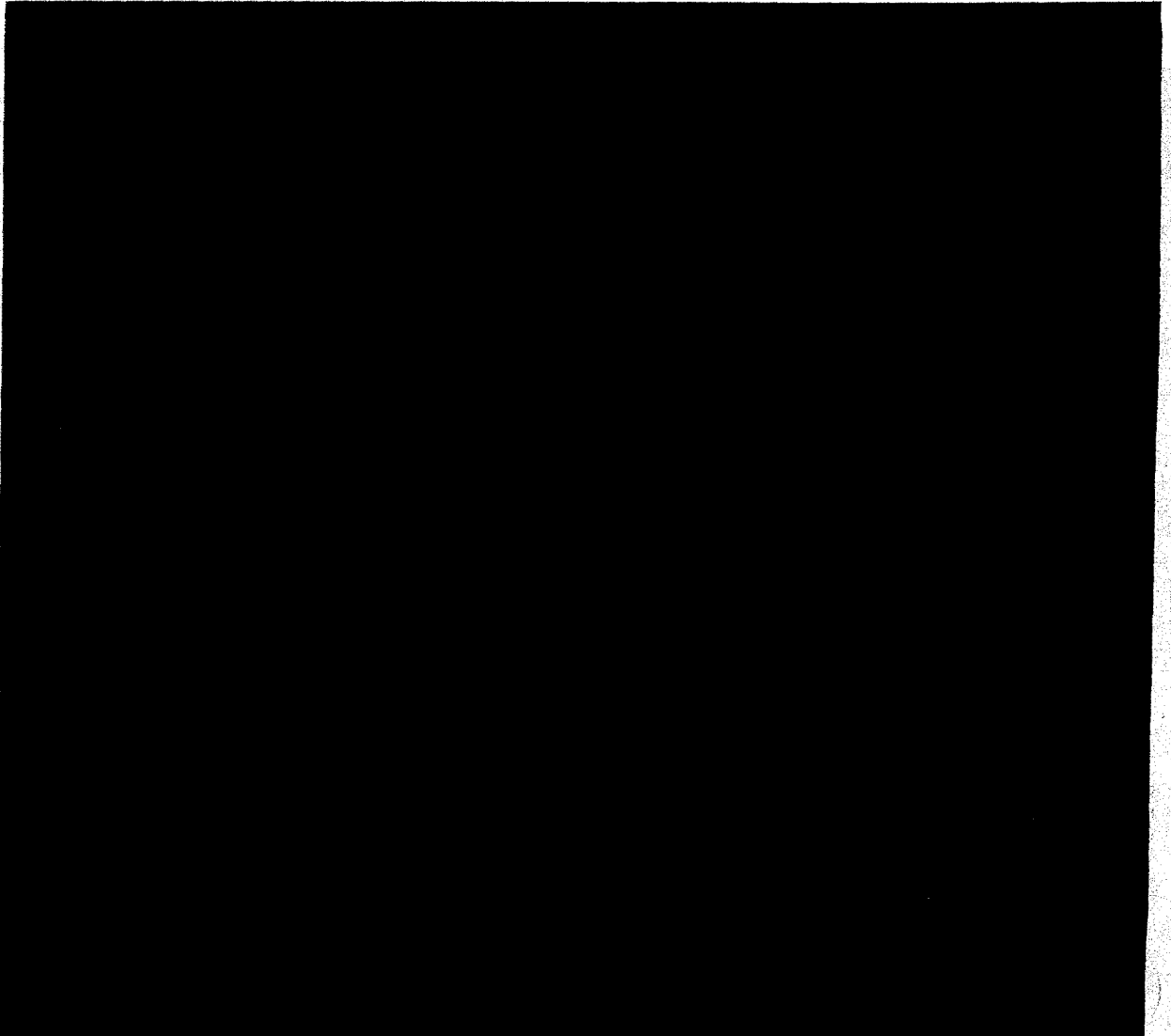

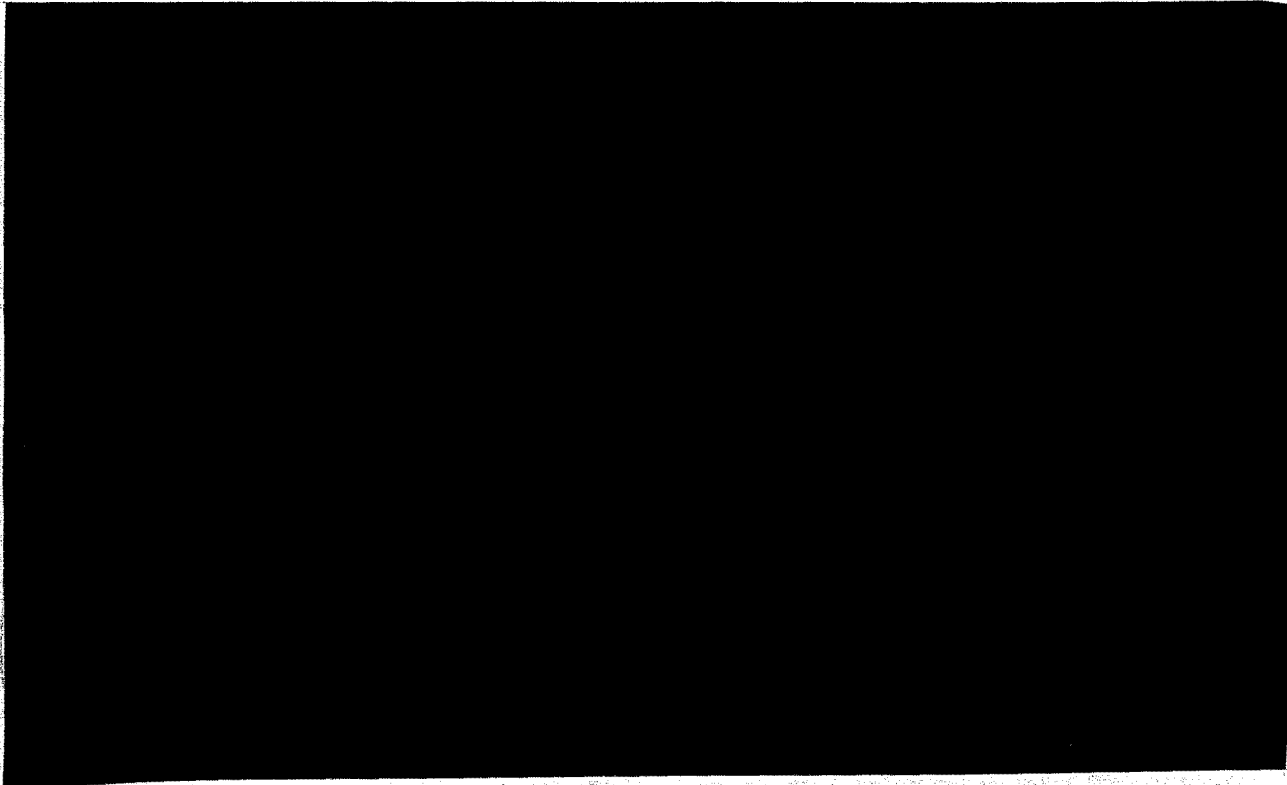
